

**GENERAL POWER OF ATTORNEY
AUTHORIZATION FOR RELEASE OF PERSONAL INFORMATION**

BONDS(S) and all rewrites: _____

TO ALL PERSONS, be it known, that I, _____ Grantor, do hereby make and grant a general and irrevocable power of attorney to BAIL BONDS UNLIMITED, THEIR CONTRACTED AGENTS, INVESTIGATORS, OR ANY ASSIGNS; and do thereupon constitute and appoint said individual(s) as my attorney-in-fact. My attorney-in-fact shall have full power and authority to do and undertake all acts on my behalf that I could do personally, with full power of substitution and revocation, including but not limited to by said authority: the right to sell, deed, buy, trade, lease, mortgage, assign, rent, or dispose of any of my present or future real or personal property, including any lands, homes, motor vehicles, motor homes, boats, airplanes, trailers, inc., without exception; the right to execute, accept undertake and perform any and all contracts in my name; the right to retain any accountant, attorney, investigator, bail enforcement agent or other advisor deemed necessary to return debts as a result of this bail contract; and the right to seize all of my assets, access all asset accounts, including but not limited to bank, savings, retirement, certificates of deposit, etc. until all debts are retired. With respect to any obligation between myself or any other obligor and the investigators or any assign has full authority to retire any outstanding debts, as he/she deems necessary. In addition to the above grants and authorities, I hereby grant BAIL BONDS UNLIMITED, THEIR CONTRACTED AGENTS, INVESTIGATORS, OR ANY ASSIGNS; a security interest in ANY AND ALL PHYSICAL AND/OR TANGIBLE ASSETS, for the purpose of securing any and all amounts which may come due under this obligation. I understand that this agreement authorizes BAIL BONDS UNLIMITED, THEIR CONTRACTED AGENTS, INVESTIGATORS, OR ANY ASSIGNS; to place its name on my home, land or vehicle title as a lien holder for the purpose of perfecting this security interest. I further agree that in the event I acquire another vehicle or any other property prior to satisfying my obligations, it too shall secure my duties under this obligation. I understand that this power of attorney authorizes BAIL BONDS UNLIMITED, THEIR CONTRACTED AGENTS, INVESTIGATORS, OR ANY ASSIGNS; to take any steps necessary to perfect its (their) security interest; i.e., duplicate title and/or lien holder status on any new or other home, and or vehicle.

I do hereby authorize, voluntarily and without coercion, the review and full disclosure of all records concerning myself whether public, probate or confidential in nature, including but not limited to the right to receive all telephone, utilities, credit, social security, criminal, medical, employment, pre-employment records; NCIC and/or law enforcement records, and the recollections and/or records of attorneys-at-law, or of other counsel representing me or another in any case, civil or criminal in which I have had an interest. Such records and/or information will include but is not limited to, any and all bank and/or other financial institutional statements or account information, tax records, medical/dental records, Postal and billing (utilities, telephone, etc.) information, all military records, credit cards, court records, criminal records, employment records, employment benefit records and social security record. Furthermore, I hereby hold harmless any and all individuals, companies, agencies, organizations or entities that act under compliance of this Waiver of privacy from any legal actions, by civil, criminal or otherwise.

This power of attorney and authorization for release of personal information shall not be affected by disability of the Grantor. This power of attorney shall remain in full force until BAIL BONDS UNLIMITED, THEIR CONTRACTED AGENTS, INVESTIGATORS, OR ANY ASSIGNS; have been supplied with an original and verified certificate of discharge and/or exoneration by the court of jurisdiction on the surety bonds listed, and ALL financial obligations of the grantor have been met.
